Horses subject to inspection by the ApHC Inspector. Entry numbers must be stamped by the ApHC inspector. Stall reservations must be made with the ApHC National Show. Current negative coggins test and health papers will be required. The decision of the judges officiating the event and/or the governing ApCHA Board of Directors is final.
