PROCEDURE:

The first person to submit a properly completed claim form and payment in full for a particular horse shall be considered the buyer and will assume ownership and custody of the horse at the conclusion of the claiming class or at the conclusion of the last class in which the horse is entered if disclosed by consignor at the time they enter the horse into the claiming class.
