Saddle Log Program

The Saddle Log Program is a great way for you to earn awards for the time you spend riding your Appaloosa. Whether you are an adult or youth, this program recognizes the personal achievements and benefits of riding on a daily basis. Whether you participate in trail rides, train and compete in shows, ride in parades, perform ranch work, or enjoy pleasure riding, each hour will count towards earning terrific awards.

How to qualify for the Saddle Log Program:

You must be a current ApHC member. Your horse must be an Appaloosa registered with the ApHC.

How to enroll for the Saddle Log Program:

Please send the completed Saddle Log Application form and the **\$15.00** annual filing fee for adults or **\$20.00 one-time filing fee for youth**, to the ApHC office.

1. For adults, your eligibility is for one year following the time the ApHC receives your application. If you sign up on July 23, 2005, your eligibility continues until July 22, 2006.
2. For youth, your eligibility begins the time the ApHC receives your application until you are over the age of 18 as of January 1.
3. All horses used must be ApHC registered Appaloosas. You may use an Appaloosa with any registration classification (#, CN, N), you may use as many ApHC registered Appaloosas as you like and you don't need to own the horse you are using to log the hours.
4. Logged hours must be recorded on official forms provided by and available from the ApHC.
5. If inactive for more than five years, your Saddle Log records will be deactivated.
6. We also have a program for disabled riders and drivers. The same rules and qualifications will apply to this program.

Awards in the Saddle Log Program:

1. Riders will receive an official Appaloosa Saddle Log Program Patch for completion of the first 100 hours of riding.
2. Official Chevron Bars will be awarded upon completion of 100, 200, 500, 1000, 1500, 2000 and 2500 hours of riding.
3. Disabled riders and drivers will be awarded Official Chevron Bars upon completion of 25, 50, 75, 100, 200, 500, 1000, 1500, 2000 and 2500 hours of riding or driving time.
